## **RECRUITMENT ANNOUNCEMENT**

**POSITION:** Public Health Nurse II – COVID-19

**STATUS:** Full - Time

### **RECRUITMENT STANDARDS:**

An employee in this classification provides quality professional nursing services to individuals and families in public health programs designed to promote health and prevent diseases. In coordination with COVID Health Planning Group develop and evolve overall strategy for an ongoing testing program, to include both population levels testing as well as strategic testing of higher risk populations to occur periodically and as needed. Establish and sustain working relationships with third party testing resources (labs). Organize on-campus and off-campus resources for collecting test samples as needed. In coordination with Health Services, establish protocols for general, asymptomatic testing process to include establishing appropriate locations and organizing systems whereby sample collection will occur in a safe and effective manner. Oversee the implementation of all population level and strategic testing strategies. Recruit, organize, train and support individuals qualified to conduct contract tracing. Establish working relationship with Local Board of Health to collaborate/communicate around testing and contact tracing practices and procedures. Maintain a database in support of testing and contracting tracing processes. Maintain current knowledge of evolving COVID testing technologies. Work is performed under general supervision and is evaluated on the basis of attainment of individual performance objectives, observation, accuracy of reports and feedback from employees and the general public. Work is performed under general supervision of department supervisory personnel. The employee is expected to exercise initiative and independent judgment in accordance with established policies and procedures.

### **MINIMUM EDUCATION AND EXPERIENCE REQUIREMENTS:**

Graduation from an accredited four- year or university with a B.S. Degree in Nursing which includes a Public Health Nursing rotation and one year of Public Health Nursing experience; or graduation from an accredited school of professional nursing and two years professional nursing experience including one year in public health; or an equivalent combination of training and experience.
